EXECUTIVE SUMMARY

According to the BIOFIN Biodiversity Finance Initiative Workbook, the main objective of the Biodiversity Expenditure Review is to apply detailed budget and expenditure data from public, private organizations and the civil society to inform and promote best practices in biodiversity finance.

Biodiversity expenditures are defined as any costs incurred by the public and private sector to positively impact, reduce or eliminate pressures on biodiversity. These expenditures may include "direct" expenditures, the primary purpose of which is to conserve biodiversity, as well as "indirect" expenditures, for secondary funding for biodiversity conservation.

Thus, from 2015 to 2022 the republican, local budgets, as well as funds of international organizations, industrial enterprises and NGOs spent on biodiversity conservation and development 1,267,015,260 thousand tenge (USD2,517,931,300), which is 1.25% of the GDP of the Republic of Kazakhstan in 2022 (GDP in 2022 103,765,518.2 million tenge) or 5.34%

of the total consolidated state budget of the country in 2022 (budget volume in 2022 22.6 trillion tenge). These expenditures include financing of measures on water, forestry, fisheries, protection of specially protected natural areas, environment and wildlife.

At the same time, government expenditures on biodiversity conservation activities are the largest, accounting for 74.75% (947,043,472.80 thousand tenge), the expenditures of international organizations are in second place in terms of volume and amount to 13.55% (171,677,972 thousand tenge), while the expenditures of NGOs and the industrial sector are insignificant, representing only 8.66% (109,736,343 thousand tenge) and 3.03% (38,799,122.44 thousand tenge) respectively.

In the next 5 years, a significant allocation of funds for biodiversity will be required increasing from 1,494.29 million tenge in 2024 to 2,392.39 million tenge in 2028, which will directly depend on the state of economic development, budget figures, strategic goals of the state and other factors.

INTRODUCTION

The BIOFIN initiative involves 41 countries to undertake a detailed review of biodiversity budgets and expenditures based on qualitative and quantitative data as part of the methodology. The outcome of the biodiversity expenditure review is a comprehensive report that reveals overall trends, challenges and opportunities in biodiversity expenditures.

In general, the BIOFIN methodology consists of five separate technical steps including policy and institutional review of biodiversity finance, biodiversity expenditure review, financial needs assessment, biodiversity finance plan, implementation of financing solutions.

To have a full picture the BIOFIN methodology should be integrated into the national context, taking into account high-level support, the willingness of sectoral ministries and agencies to cooperate, addressing proposals in budget and management reforms, the provision of financial data and information, and the availability of basic capacity for technical work.

This report reviews biodiversity spendings in the Republic of Kazakhstan from 2015 to 2022 under the BIOFIN methodology of 2018.

The first part of the report identifies the current level of public and private sector funding for biodiversity. The second part assesses future needs and forecasts the amount of financial resources for biodiversity conservation. The allocated funds for biodiversity are divided into direct and indirect.

The sources of information and statistics presented in this analysis are reports and materials provided by government agencies, international organizations and industrial companies through official request on behalf of UNDP in Kazakhstan.

Together with the BIOFIN team, the percentages of each activity in the budgets of budget programme administrators were determined. The fundamental factor in allocating the percentages of expenditures directly and indirectly affecting biodiversity was compliance and non-compliance with the 3 main objectives of the Convention on Biological Diversity (conservation of biological diversity; use of biological diversity without destroying it; fair and equitable benefit sharing associated with the use of genetic resources).

1. STATE PLANNING SYSTEM DOCUMENTS

The system of state planning in the Republic of Kazakhstan is a complex of interrelated elements consisting of principles, documents, processes and participants of state planning, ensuring the development of the country for long-term (over 5 years), medium-term (from one year to 5 years inclusive) periods.

Thus, in accordance with the Resolution of the Government of the Republic of Kazakhstan dated April 29, 2024 No. 350, the structure of documents of the State Planning System by hierarchical importance is as follows:

Along with this, the documents of the State Planning System represent an integral system, where the necessity and legitimacy of the development of documents of the lower level derive from the documents of the higher level, and the monitoring and evaluation of the documents of the higher level are carried out based on reliable information on the implementation of documents of the lower levels. Target indicators and performance indicators of the documents of the State Planning System should be decomposed and determined based on their hierarchy.

Accordingly, the documents of the state planning system were analyzed for the presence of strategic goals of the Republic of Kazakhstan for the coming future in the field of biodiversity conservation, including issues on environmental protection measures, development of forestry, fisheries, wildlife, environmental regulation, environmental protection, use of wildlife resources and other areas (Table 1).

There are no state strategic aims in the field of biodiversity conservation in the high-level documents of the state planning system, including the Development Strategy of Kazakhstan until 2050 (first level) and the National Priorities (second level).

However, the third level documents including the Strategic Development Plan of the Republic of Kazakhstan until 2025 and the sixth level documents including the Development Plan of the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan for 2020-2024 contain strategic aims on biodiversity conservation.

At the same time, in accordance with the principles of hierarchy of documents of the state planning system, target indicators and performance indicators should be decomposed and defined based on their hierarchy, i.e. there should be a clear reference of aims from the Development Strategy of Kazakhstan until 2050 and National Priorities to lower-level documents of biodiversity activities. However, these measures have not been confirmed in the higher-level documents.

The above mentioned confirms the weak planning at the level of state administration and the lack of coherence in strategic aims between the levels of state planning, whereby the aims in higher-level documents are not cascaded to lower-level ones (According to Resolution No. 790, cascading is the process of dividing the aims, target indicators, objectives and result indicators of higher-level documents of the State Planning System into constituent aims, target indicators, objectives and result indicators to reflect them in lower-level documents of the State Planning System).

Thus, according to Objective 7 "Conservation of biological diversity" of the Strategic Development Plan of the Republic of Kazakhstan until 2025, which is a mediumterm state planning document, the main aims of the country until 2025 are indicated, namely:

- By 2025 there are plans to create two more national parks, three natural reserves and bring the area of specially protected natural areas of Kazakhstan to 10-12% of the country's area (To preserve endemic, rare and endangered species, unique reference sites and natural ecosystems, efforts to increase the area of specially protected natural areas will be maintained)
- Increasing the wooded area and increasing it to 4.8%

- Preservation of the state natural reserve fund objects
- Preservation and increase in the number of wild animals, including rare and endangered ones
- Development of captive and semi-captive game breeding
- Preservation of fish species population and development of commercial fish farming and aquaculture.
- Systematic solution to the problem of land degradation and desertification (within

- the framework of the national strategy of sustainable land management)
- Increasing the volume of forest regeneration and afforestation, creation of green zones around regional centers, development of private afforestation.

Also, according to the Development Plan of the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan for 2020-2024, two strategic directions are assigned to this ministry:

1. Improvement of quality

1.1. "Creating conditions for transition to a "green economy"

2. TOTAL BIODIVERSITY BUDGET AND EXPENDITURES AT THE NATIONAL LEVEL

This section includes an analysis of total republican budget revenues and expenditures, inflation and gross domestic product in the Republic of Kazakhstan from 2015 to 2022.

The information was obtained from the Internet resources of the Bureau of National Statistics of the Agency for Strategic Planning and Reforms of the Republic of Kazakhstan, the Ministry of Finance of the Republic of Kazakhstan and the National Bank of the Republic of Kazakhstan.

In accordance with the Budget Code of the Republic of Kazakhstan, the budget is a centralized monetary fund of the state, designed to financially ensure the implementation of its tasks and functions. The budgetary system is a set of budgets and the National Fund of the Republic of Kazakhstan, as well as budgetary process and relations.

In the Republic of Kazakhstan, the state budget is four-tiered, which includes:


- 1) the republican budget;
- 2) regional budget, budgets of the city of republican significance, the capital;

- 3) district (cities of regional significance) budget;
- 4) budgets of the city of district significance, village, settlement, rural district.

The budget of the Government of the Republic of Kazakhstan for the reporting periods showed steady growth. Revenues of the country grew from 7,634,804.9 thousand tenge in 2015 to 16,141,603 thousand tenge in 2022. Thus, actual revenues increased by 111.4%.

Budget expenditures for the same period also increased significantly from 8,227,097.2 thousand tenge in 2015 to 18,795,060.2 thousand tenge in 2022, which in percentage terms amounted to 128.4% growth, or 2.3 times.

The budget deficit in tenge terms increased from – 915,704.8 in 2015 to – 2,390,848.2 thousand tenge. In 2022, that is 161% growth. However, the budget deficit in relation to Gross Domestic Product (hereinafter - GDP) was in the range from -2.2 in 2015 to - 2.3 in 2022, which indirectly characterizes positive and moderate GDP growth (Figure 1).



To summarize, it is noted that from 2015 to 2022, total revenues to the budget of the country amounted to 98.5 trillion tenge, and expenditures for these periods amounted to 108.5 trillion tenge, with a budget deficit of 9.9 trillion tenge over 8 years.

Gross Domestic Product in the Republic of Kazakhstan since 2015 shows moderate growth with periods of slowing growth in 2020, as well as periods of accelerating growth in 2018, 2021 and 2022. Real economic growth, expressed in the economic indicator of GDP, directly affects the formation of the state budget of the Republic of Kazakhstan, as economic activity in the country contributes to the expansion of the tax base and budget revenues (Figure 2)¹.



Thus, along with real productivity growth in the economy, there is an increase in the volume of the state budget, which is positively correlated with the dynamics of GDP growth from 2015 to 2022.


At the same time, it is essential to take into account inflationary growth in the country, which averaged 9% annually (Figure 3)².

Rising inflation in the country causes a sharp decline in private and public investment, which in turn leads to a slowdown in economic growth (Figure 4).





Direct investment in Kazakhstan comprises investments in direct investment Kazakh enterprises, with net direct investment inflows showing a steady decline since 2015 in the economic sectors of agriculture, forestry and fisheries³.

Moreover, devaluation of the tenge exchange rate in different periods increased pressure on prices, triggered additional growth of inflation rates and reduced investment attractiveness of various sectors of the economy (Figure 5)⁴.



2.1. Structure of the republican budget revenues

By the structure of revenues or income, the republican budget consists of 5 main sources of income, including tax revenues, transfers from the National Fund of the Republic

of Kazakhstan (hereinafter – NF), non-tax revenues, inflow from the sale of fixed capital and grants (Figure 6).

At the same time, the largest part of revenues to the republican budget is tax revenues 63.16%, which includes the following types of payments to income:

01 Income tax

2.2. Tax and other revenues in the area of biodiversity

According to the Methodology for determining the rates of fees for the use of wildlife, approved by the order of the Minister of Agriculture of the Republic of Kazakhstan from November 18, 2015 Nº 18-03/1010 determination of the rates of fees for the use of wildlife is based on:

- normative limit of extraction norms of withdrawal of animal species that are objects of hunting, approved by the authorized body in accordance with subparagraph 5) of paragraph 1 of Article 9 of the Law;
- 2) animal surplus and extraction coefficients;
- 3) quantity of animals (animal parts and derivatives removed from the habitat).

At the same time, the payers of the fee are persons who have obtained the right to special use of wildlife in accordance with the procedure determined by the legislation of the Republic of Kazakhstan.


The fee for the use of SPNA (hereinafter the fee) is charged for the use of SPNA of the Republic of Kazakhstan within the outer boundaries of SPNA (except for the areas of state natural monuments, state natural reserves, state protected zones) for scientific, ecological-enlightenment, cultural-educational, educational, tourist, recreational and limited economic purposes defined by the Law of the Republic of Kazakhstan "On Specially Protected Natural Areas". The fee is charged for the use of SPNA, located on land plots within the outer boundaries of SPNA and used for purposes regardless of the intended purpose of land plots and their belonging to any category of land.

Payers are individuals and legal entities using SPNA of the Republic of Kazakhstan. Thus, in the Republic of Kazakhstan various types of revenues for the use of natural and other resources, including:

According to the analysis of the trend of tax revenues in the field of biodiversity, the largest volume of tax revenues to the state budget is the payment for negative impact on the environment, which accounts for more than 80% of budget revenues in this area (Table 1)⁵.

According to the National Report "On Implementation of the Extractive Industries Transparency Initiative in the Republic of Kazakhstan" the largest amounts for emission fees into the environment in 2021 are paid by Tengizchevroil LLP for 17,894,100 thousand tenge or 26% of the total amount paid by all subsoil users, AZ Minerals Aktogay LLP (KAZ Minerals Aktogay) for 4,875,700 thousand tenge or 7.09%. 4,875,700 thousand or 7.09%, JSC "ArcelorMittal Temirtau" - 4,856,400 thousand or 7.06%,

JSC "SNRS-Aktobemunaigas" – 3,738,000 thousand or 5.43%, JSC "Sokolovsko-Sarbai Mining and Processing Production Association" – 3,690,100 thousand or 5.36%, the share of payment for issues of Kazphosphate LLP is 4.9% or 3,355,000 thousand.

The smallest amount of fees according to TOP 20 subsoil user companies was made by Bogatyr Komir LLP – 594,100 thousand tenge or 0.9%.

In accordance with paragraph 6 of Article 322, paragraph 6 of the Environmental Code of the Republic of Kazakhstan, the collected amounts of damage compensation are transferred to the state budget.

In accordance with the order of the Minister of Finance of the Republic of Kazakhstan from April 23, 2010 Nº 183 "On approval of the table of distribution of budget revenues between the levels of budgets and cash control account of the National Fund of the Republic of Kazakhstan" funds received from users of natural resources on claims for compensation for damage, except for revenues from organizations of the oil sector, as well as funds from the sale of confiscated hunting and fishing gear, illegally extracted products are subject to enrollment in the national budget.


At the same time, funds received from natural resource users on claims for compensation of damage by oil sector organizations are subject to enrollment in the National Fund of the Republic of Kazakhstan. These payments are credited in the form of income under the advised codes of payments according to the Rules of crediting assets to the National Fund of the Republic of Kazakhstan and use of the National Fund of the Republic of Kazakhstan, as well as the forms and Rules of drawing up an annual report on the formation and

use of the National Fund of the Republic of Kazakhstan, approved by the Resolution of the Government of the Republic of Kazakhstan dated April 23, 2015 Nº 267.

In turn, the expenditures of the National Fund are carried out in the form of guaranteed transfers transferred from the National Fund to the republican budget and in the form of targeted transfers transferred from the National Fund to the republican budget for the purposes determined by the President of the Republic of Kazakhstan. Thus, the target nature of allocation of funds is lost, which makes it impossible to track the direction of allocation of funds from the National Fund for such activities as financing of biodiversity.


By virtue of paragraph 3 of Article 22 of the Budget Code of the Republic of Kazakhstan, the organizations of the oil sector include legal entities engaged in the production and (or) sale of crude oil, gas condensate, as well as concluded contracts for the exploration of crude oil, gas condensate.

The total amount of funds received from natural resource users on claims for compensation for damage, except for revenues from oil sector organizations, as well as funds from the sale of confiscated hunting and fishing gear, illegally extracted products from 2015 to 2022 amounted to 20,033,689 thousand tenge (Figure 8).





The Order of the Acting Minister of Finance of the Republic of Kazakhstan dated August 20, 2019, No. 901 amended and supplemented the Order of the Minister of Finance of the Republic of Kazakhstan dated September 18, 2014, No. 403 "On Approval of the Unified Budget Classification", which added a new BCC 204173 "Administrative fines, penalties, sanctions, penalties imposed by the Ministry of Ecology, Geology and Natural Resources of the Republic of Kazakhstan, its territorial bodies, financed from the republican budget, except for inflow from organizations of the oil sector" from August 21, 2019 (Figure 9).

Payment for the use of navigable waterways on the basis of a permit document issued by the authorized state body on transport control issues for each calendar year. Payers are individuals and legal entities using navigable waterways of the Republic of Kazakhstan. The amount of the levied fee for shipowners is set based on the actual period of use of navigable waterways of the Republic of Kazakhstan (Figure 10).

As of 2018, amendments were made to the Tax Code of the Republic of Kazakhstan, under which inefficient payments, including

fees for the use of navigable waterways, were canceled, as the state does not provide services and permits in this case.

2.3. Fees for the use of Protected Areas

In accordance with the Law of the Republic of Kazakhstan dated July 7, 2006 No. 175 "On Specially Protected Natural Territories", a specially protected natural area is an area of land, water bodies and airspace above them with natural complexes and objects of the state natural reserve fund, for which a special protection regime is established

According to Article 589 of the Tax Code of the Republic of Kazakhstan, payment for the use of specially protected natural areas (hereinafter – SPNA) is levied within their external boundaries. It should be noted that in the absence of a special account opened with the treasury authorities or second-tier banks, the State Nature Sanctuary does not provide paid services.

Revenues of SPNA come in the form of transfers (014) and in the form of charitable assistance, which reflects the amount of income from philanthropic and (or) sponsorship and (or) patronage activities (017).


From 2015 to 2022 the total amount of money inflow from rendering paid services under SNPA was 1,486,116.2 thousand tenge.

Funds received by state entities in the spheres of forestry, specially protected natural areas from the provision of paid activities for the sale of goods (works, services) are spent on:

- carrying out forestry activities on the plots of the state forest fund;
- 2) construction and maintenance of forestry roads, firefighting equipment of forests;
- 3) design and survey works in the field of protection, defense, use of the forest fund, forest reproduction and afforestation;
- 4) payment for the work (services) of freelance seasonal workers to ensure environmental protection activities, including fire watchmen, workers for intermediate and other felling, silvicultural work, as well as workers engaged in processing of forest resources;

- 5) acquisition of means of communication, transportation and equipment, mechanisms and materials for firefighting, forest protection and silvicultural purposes, seeds and planting materials for silvicultural works, petroleum, oil and lubricants, uniforms, weapons and special means of protection;
- 6) purchase of equipment and mechanisms necessary for processing of forest resources;
- 7) construction, reconstruction and repair of buildings, structures and other facilities related to the functioning of forest entities;
- 8) training and professional development of specialists for forestry and hunting;
- 9) encouragement of employees of forest institutions for labor performance.

Ile-Alatau State National Nature Park is the largest fund recipient from revenues collected from paid services among other SPNAs in the Republic of Kazakhstan (Figure 11).

3. BIODIVERSITY EXPENDITURE BASELINE AND COST-EFFECTIVENESS REVIEW

This section examines public and private expenditures for biodiversity conservation, which have indirect and direct impact.

Public expenditures include budget programmes and subprogrammes implemented by the republican and local budgets.

Private expenditures include own funds of environmental institutions, through the

provision of paid services, funds allocated by international and other organizations, and expenditures for environmental activities of industrial companies.

Direct expenditures are the expenditures directly related to biodiversity conservation, which according to Table 5 BIOFIN categories (BIOFIN's Biodiversity Finance Initiative Workbook 2018) divided into 9 categories:

3.1. Financing biodiversity from the republican budget

The state budget of the Republic of Kazakhstan, which includes the republican and local budgets, is socially oriented, with the majority of budget expenditures aimed at financing social assistance and social security 27.18%, as well as health care 11.34% of the population.


From 2015-2022 the volume of financing of biodiversity from the republican budget amounted to 2.2%.

According to the Rules of budget execution and its cash services, approved by the order of the Minister of Finance of the Republic of Kazakhstan dated December 4, 2014 Nº 540 (hereinafter – Rules Nº 540) in the Consolidated Plan of revenues and financing on payments state expenditures are classified into 12 main directions of state policy:

- 01 Government services of a general nature;
- 02 Defense;
- 03 Public order, security, legal, judicial, criminal-executive activity;
- 04 Education;
- 05 Health care;
- 06 Social assistance and social security;
- 07 Housing and communal services;
- 08 Culture, sports, tourism and information space;
- 09 Fuel and energy complex and subsoil use
- 10 Agriculture, water, forestry, fisheries, specially protected natural territories, environment and wildlife protection;
- 11 Industry, architectural, town-planning and construction activities
- 12 Transportation and communications

For seven years in the Republic of Kazakhstan only 2.17% of budget expenditures or 1,825,602,500 thousand tenge have been


spent on agriculture, water, forestry, fisheries, SPNAs, environmental protection and wildlife, land relations (Direction 10) (Figure 12).

Expenditures on agriculture, water, forestry, fisheries, specially protected natural territories, environmental protection, wildlife,

and land relations account for 2.2% of the total volume of republican budget expenditures over 8 years (Figure 13).

Total expenditures of the republican budget from 2015 to 2022 amounted to 82,733,728,462.00 thousand tenge (116.9% growth), with expenditures on agriculture, water, forestry, fisheries, SPNA, environmental protection and wildlife, land relations from 2015 to 2022 amounted to 1,825,602,500.00 thousand tenge (90.3% growth).

In order to determine the exact expenditures on biodiversity, it is necessary to exclude the expenditures on agriculture and land relations, which account for most of the expenditures in the direction of Section 10.

The Ministry of Finance of the Republic of Kazakhstan in the formation of reporting on budget execution and consolidated financial statements on an accrual basis group Section 10 into one general type of costs in accordance with the budget legislation.

At the same time, expenditures only on water management, environmental protection, fisheries, forestry and wildlife amounted to 538,405,692.00 thousand tenge or 0.65% of the total expenditures of the republican budget for 8 years.



Water management:

Spent - 295,395,148.00 thousand tenge

For construction and reconstruction of water supply system, hydraulic structures, overhaul and rehabilitation of especially emergency sections of inter-farm canals and hydromeliorative structures, regulation of water fund use and protection, ensuring functioning of water management systems and structures and other expenditures.



Environmental protection:

Spent - 75,130,842.00 thousand tenge

For the design of qualitative and quantitative indicators (environmental standards and requirements), scientific research in the field of environmental protection, construction and reconstruction of environmental protection facilities, conducting observations of the state of the environment and other expenditures.



Fisheries, forestry and wildlife:


Spent - 167,879,702.00 thousand tenge

To manage forestry, ensure conservation and development of forest resources and wildlife, conservation and reproduction of fish resources and other aquatic animals, protection, defense, regeneration of forests and wildlife.

The largest expenditure amount from the republican budget was associated with expenditures related to the financing of measures in the field of water management, for which 0.36% of the total volume of expenditures of the republican budget was spent over 8 years.

Then financing of measures in the field of fisheries, forestry and wildlife, for which 0.2% of the total volume of expenditures of the republican budget was spent.

The least amount of funds from the budget was spent on environmental protection, with this direction accounting for only 0.09% (Figure 14).

3.2. Institutional reforms in public administration

In various periods, the Republic of Kazakhstan has undergone institutional transformations in the field of public administration.

The Decree of the President of the Republic of Kazakhstan "On Reform of the Public Administration System of the Republic of Kazakhstan" dated August 6, 2014 started the process of optimization of the state apparatus and formation of a compact Government of the Republic of Kazakhstan to modernize and improve the efficiency of the public administration system.

A number of ministries and agencies have been renamed, transformed, created, separated, merged into others, and liquidated depending on the tasks and goals set by the country's leadership to:

- Optimizing the distribution of roles and powers in order to ensure the effective functioning of the government
- Introducing new instruments in public policy
- Prepare a "platform" for the development of dialog with the public
- Strengthening and increasing the autonomy of local governments
- Giving local executive bodies more freedom in the management of budgetary money
- and other tasks.

The use of budget funds is carried out strictly for the intended purpose.



MENR departments, as well as the line ministry itself represented by MENR had high budget utilization with minimal balances (budget savings), apart from FWC MENR, which had a savings of 97,068,710 tenge. At the same time, the subordinate organizations of FWC MENR represented

by protected areas had a significant budget deficit. This fact indicates weak execution of the state budget of the FWC MENR and its subordinate organizations (more detailed budget information is given in the Annex to this report).


In 26 SNPAs there was an acute budget deficit, with actual cash expenditures exceeding the budgeted amounts. Thus, the largest budget deficit was observed in SPNAs on SNNP Ile-Alatau, SFNS "Semey Ormani", SNNP "Kokshetau", SNNP Burabai UDP RK and SNNP "Kolsai kolderi". This indicates weak budget planning.

Therefore, with the lack of funds from the state budget, SPNAs carry out expenditure operations at the expense of funds of the FWC MENR and OPA, that is, at the expense of the administrator of budget programmes.

In order to effectively finance activities of SPNAs in cooperation with FWC MENR, it is necessary to improve the mechanism of budget planning at the stage of submitting a budget request to the MFRK.

In Burabay SNNP of MENR there is a similar situation, moreover in 2020 the Smart National Park Burabay system for early detection of forest and steppe fires was introduced in this national park for the total amount of 761.7 million tenge from the national budget, which was not approved at the planning stage, as budget adjustments were made at the end of 2020 by increasing the amount of the budget.

3.5. Biodiversity funding from local budgets

According to the Budget Code of the Republic of Kazakhstan dated December 4, 2008, No. 95-IV, a four-level budget is approved, executed and independent in the Republic of Kazakhstan, consisting of the following levels:

- 1) republican budget;
- 2) regional budget, budgets of the city of republican significance, capital city;
- 3) district (cities of regional significance) budget;
- 4) budgets of the city of regional significance, village, settlement, rural district.

At the same time, regional budget, budgets of the city of republican significance, capital, district (cities of regional significance) budget, budgets of the city of district significance, village, settlement, rural district are referred to local budgets.

The information on local executive authorities includes the following key public entities of the local budget (regional and district budgets).



Information is obtained on the "top" level of data on the execution of local budgets at the level of regions (except for 2016 and 2017, as the data of the year in the context of each region in the integrated treasury information system was not available, but the information will be displayed at the level of the republic).

The amount of local budget showed steady growth starting from 3,525,572,351.0 thousand tenge in 2015 and up to 13,679,336,195.0 thousand tenge in 2022.

Total expenditures on water management, environmental protection, fisheries, forestry and wildlife from local budgets amounted to 408,637,780.80 thousand tenge or 0.81% of the total expenditures of local budgets for 8 years (Figure 15).

Thus, the actual growth of total local budget expenditures for 8 years amounted to 288%, while the actual growth of expenditures on biodiversity amounted to only 134.2%. Budget expenditures are allocated disproportionately to biodiversity financing activities.

From 2020, the corporate income tax for SMEs was transferred to local budgets to increase the self-sufficiency of local budgets and strengthen the autonomy of decision-making at the level of local executive bodies. Moreover, in 2022, there was a positive GDP


growth due to the end of the coronavirus pandemic and SMEs were actively operating, while paying mandatory tax payments to the budget. Along with this, the expenditure side was also significantly increased.



Water management:




From 2015 to 2022, the total adopted budget for the regions, cities of republican significance and the capital amounted cumulatively to 45,343.63 billion tenge.

In accordance with the principles of local self-government, local executive authorities develop and independently execute the budget of the respective administrative-territorial units.

The largest budget volumes from 2015 to 2022 (over 8 years) are in Astana city (5,876.18 billion tenge), Almaty city (3,979.87 billion tenge) and Turkestan region (4,471.86 billion tenge).

The least amount of budgets from 2015 to 2022 (over 8 years) of observations comes to the newly formed regions of Zhetisu (495.82 billion tenge), Ulytau (171.78 billion tenge) and Abai (347.73 billion tenge) (Figure 20).



Along with this, if we take into account the percentage ratio of the approved budget and the amount of spending on biodiversity, the North Kazakhstan (16.9%), Almaty (11.9%) and Kostanay (10.6%) regions have the largest amount of allocated budget funds

for activities to finance water, forestry and fisheries, as well as wildlife and environmental protection. At the same time, the smallest accounts for Almaty city (1.4%), Abay (1.5%) and Ulytau oblasts (1.3%).





3.6. Private sector

Financing biodiversity with UNDP engagement

UNDP in the Republic of Kazakhstan in the period from 2015 to 2022 implemented 10 projects in the field of biodiversity conservation for a total amount of USD16,218,093 allocated by donors (Global Environment Facility, the Governments of Germany, Switzerland, the United Kingdom, Canada and the European Union and blockchain company Bitfury).

Public expenditures of the Government of the Republic of Kazakhstan, which are co-financed from the republican budget and funds of local executive bodies, were excluded from this category of expenditures in order to avoid double counting. Thus, the above-mentioned budget expenditures are indicated in Sections 3.1 and 3.5 of this report in the budget programmes of the respective state institution.

 under the project "Conservation and sustainable management of key globally critical ecosystems for multiple benefits". The overall budget of the project is USD8,069,178 for 2018-2023. The main objective of the project is to comprehensively address the issues of conservation and sustainable use of forest ecosystems in Kazakhstan through improved management approaches.

For the development of mountain and forest ecosystems in Almaty, East Kazakhstan, Turkestan and Zhambyl regions, USD8,069,178 has been allocated from the Global Environment Facility (GEF) budget. The project was implemented by UNDP with co-financing from the republican budget in the amount of USD86,795,676.

Within the framework of this project, preparation of a natural science project on expansion of 3 pilot SPNAs and creation of a new one was achieved, management mechanisms of 14 pilot SPNAs were improved, 9 off-road vehicles, 22 quadrocopters and 2 motorboats were purchased, existing methods of growing saxaul forest plants were assessed and other directions were made.

2) on the project "Assisting the Republic of Kazakhstan in fulfilling international commitments to reduce greenhouse gas emissions by reducing the carbon footprint of electricity suppliers for leading technology company Bitfury".

The main objective of this project is to implement comprehensive measures in Kazakhstan to absorb CO₂ emissions by forest ecosystems. East Kazakhstan and Pavlodar regions were selected as pilot regions.

The main donor for this project was the blockchain company Bitfury, an industrial cryptocurrency miner, which allocated USD798,750.

During the project implementation an inventory of unrecorded forests of East Kazakhstan region was conducted, as well as field work was carried out to clarify the boundaries of unrecorded forests. The composition of tree and shrub species growing on each plot was determined, primary cartographic materials were developed, and the coordinates of corner points for each plot were determined.

3) under the project "Creation of conditions for reintroduction of the Turanian tiger and assistance in preservation of natural and historical-cultural objects of the Ulytau mountain range".

The given project is a joint project with the Committee of Forestry and Wildlife of MENR for the period from 2021 to 2025.

The main objective is to create conditions for the reintroduction of the extinct population of the Turanian tiger, conservation and rational use of natural and historical heritage sites, creation of the foundations for the development of Ulytau tourism. This project includes implementation of activities on the territory of Almaty region in the Pribalkhash area and Ulytau region.

The project budget is USD1,203,694 at the expense of MENR under the budget programme 036 «Creating conditions for the reintroduction of the Turanian tiger and contributing to the preservation of natural and historical and cultural sites of the Ulytau mountain range».

4) on the Biodiversity Finance Initiative (BIOFIN) Phase 2 project.

This project is targeted for 2019-2027 with the main objective of building institutional and legal frameworks to mobilize financial resources for biodiversity through new financing solutions with a budget of USD1,900,000.

The Government of Germany has allocated USD500,000 for 2022-2025 and the Government of Switzerland has allocated USD360,000 for 2022-2024.

5) on the project "Support to the Government of the Republic of Kazakhstan in the implementation of the Concept of Transition to Green Economy and Institutionalization of the Green Bridge Partnership Programme".

The project was implemented from 2015 to 2017 with the main objective of developing a Solar Atlas of Kazakhstan. This atlas was presented at EXPGO-2017 and provides insights for the implementation of ideas on the introduction and use of renewable energy sources.

The total budget of the project was USD855,410 allocated as a related grant from the Ministry of Energy of the Republic of Kazakhstan under the budget programme 034 "Implementation of the Green Economy Transition Concept and the Green Bridge Partnership Programme".

6) on the project "Technical Support for Designated Parties in the Preparation of the Sixth National Report for the CWR".

Within the framework of this project for 2018-2019, the 6th National Report on Biodiversity of Kazakhstan was prepared with information on implemented activities for the period from 2013 to 2017 on the development of SPNAs, fisheries, wildlife and hunting management, sustainable agriculture and agrobiodiversity, as well as biodiversity conservation in the industrial sector.

The donor represented by the GEF has allocated USD100,000.

7) on the project "Enhancing the sustainability of the protected areas in desert ecosystems through the promotion of biodiversity compatible livelihoods in and around protected areas".

The main objectives of the project for 2013-2018 were implementation of master's programme universities. in assistance in expansion of the territory of the SNNP, establishment of the Visit Center, methodological assistance, activities to reduce land degradation, development of an information system for biodiversity monitoring, introduction of space monitoring of desertification, micro-crediting through "Eco Damu" and other activities.

The total budget of this project is USD23,543,293, of which USD4,364,000 is allocated from GEF. In-kind contributions include UNDP USD700,000, Government of the Republic of Kazakhstan USD12,629,954, International Financial Center "Astana" USD185,520, NGOs USD1,040,200, private sector USD1,286,667 and other organizations USD3,3336,952.

 on the project "Economic evaluation mechanisms to improve decisionmaking and compliance management under global environmental agreements (CB2)". This project is designed for 2015-2017 with the aim to implement the assessment of biological resources in accordance with international obligations of the Convention on Biodiversity (CBD), the Convention to Combat Desertification and Drought, the UN Framework Convention on Climate Change and the Convention on Environmental Impact Assessment in a Transboundary Context. As a result of the project, recommendations on integrating methodologies for the economic of ecosystem services valuation prepared and methodological approaches for assessing the uptake and emission of greenhouse gases by forest and grassland ecosystems were developed. The project budget amounted to USD500,000 allocated by the GEF.

9) for the Biodiversity Finance Initiative (BIOFIN) Phase 1 project.

In the period from 2014 to 2018, a comprehensive assessment of external and internal factors, strategies, policies and practices affecting trends in biodiversity and ecosystems was carried out, resulting in the development of a Biodiversity Financing Plan for forestry, hunting, eco-tourism, protected areas and agriculture.

For this project the Governments of Germany, Switzerland and the European Union have allocated funds in the amount of USD580,000.

10) on the project "Improvement of the system of planning, monitoring, conservation and effective use of natural resources in the context of the transition of the Republic of Kazakhstan to a green economy".

Within the framework of this project from 2014 to 2016, international experience in sustainable wildlife/hunting management was analyzed. As a result of the project, a cartographic basis for the spread of zoonotic diseases in hunting farms was created, an Atlas of the spread of bacterial and viral zoonotic infections in protected areas and hunting farms of the Republic of Kazakhstan was developed, a project with the GEF


Small Grants Programme on biodiversity conservation and sustainable use of wildlife was implemented as part of the umbrella project of the Small Grants Programme on Key Ornithological Areas and other areas.

The project budget amounted to USD487,455 allocated as a related grant by the Government of the Republic of Kazakhstan represented by the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan under the budget programme 044 "Facilitating Kazakhstan's accelerated transition to a green economy by promoting technologies and best practices, business development and investment".

Republican Civic association "Kazakhstan Association for Biodiversity Conservation"

The Kazakhstan Association for Conservation of Biodiversity (KACBIO) is an association of legal entities providing project and consulting services in the field of biodiversity conservation. This organization has been operating since 2004 and has 9 branches in the Republic of Kazakhstan. The main mission is the conservation of wildlife in Kazakhstan and environmental education of the population.

From 2015 to 2022 KACBIO has implemented 160 projects in the field of biodiversity conservation for a total amount of 3,160,040,366.88 tenge received in the form of state order, international grant and sponsorship from Kazakhstan corporate sector.



The largest donors out of 50 who provided funds for KACBIO were The Royal Society for the Protection of Birds, Michael Succow Foundation, Fauna & Flora International, Tengizchevroil LLP, Bulgarin Society for the Protection of Birds Frankfurt Zoological Society and Conservation International Foundation, which accounted for 1/3 of all funds.

The main activities of KACBIO included:


- studying the nesting of gyrfalcon in central Kazakhstan
- conservation of the red-breasted goose along the global flyway
- Altyn Dala conservation initiative: Kulans
- capacity building and assistance in combating wildlife crime in Central Asia
- promoting cooperative biodiversity conservation in the Dzungaria Ecological Corridor in Kazakhstan"

Saiga Conservation: Altyn Dala steppe conservation initiative

Kazakhstan Biodiversity Conservation Corporate Fund

The Kazakhstan Biodiversity Conservation Fund (KBCF) has been financing projects since 2007 by consolidating funds received from various donors for the implementation of activities on biodiversity conservation and sustainable nature management through the provision of grant support to individuals and legal entities.

KBCF has implemented 20 projects from 2015 to 2022 for a total amount of 1,693,443,029 tenge.



The largest donors of the 14 KBCF donors were ERG Komek, Coca-Cola Company, Aksu TPP, Forestry Service of the Republic of Korea, WWF Russia, Global Water Challenge, Critical Ecosystems Partnership Fund (CEPF) and JSC Varvarinskoye Polymetal.

The main activities of the KBCF included:

 sponsorship support in the creation of conditions and preservation of biodiversity of the Korgalzhyn reserve and realization of the festival "Flamingo"

- preservation of biodiversity of ichthyofauna of the transboundary Irtysh River
- "Phytoremediation of the dried Aral Sea bottom in Kyzylorda oblast"
- rehabilitation of abandoned irrigated lands by providing water supply and rehabilitation of irrigation network and creation of water collectors.

European Bank for Reconstruction and Development

The main objective of the European Bank for Reconstruction and Development (EBRD) is to invest in projects and business development for the transition to open market economies in 30 countries in Central and Eastern Europe, as well as Central Asia and the Mediterranean. The EBRD is the largest investor in the Republic of Kazakhstan.

As part of its Green Economy Transition Policy from 2021 to 2025, the EBRD is helping countries to build green, low-carbon and sustainable economies

The total amount of EBRD financing in support of biodiversity and positive environmental impacts in Kazakhstan from 2015 to 2022 amounted to 316.3 million euros or 159.8 billion tenge. At the same time, EBRD investments are being made using the Bank's existing financial instruments as part of the transition to a green economy in the region.

Asian Development Bank

The Asian Development Bank (ADB) is a multilateral development financial institution with the primary objective of stimulating economic growth in Asia through direct borrowing and technical assistance.

ADB had an indirect impact on biodiversity financing in the Republic of Kazakhstan. Thus, within the framework of the Central Asia Regional Economic Cooperation Corridors 1 and 6 (Aktobe – Kandyagash) link road reconstruction project, ADB has prepared an environmental monitoring report jointly with the national company KazAutoZhol.

Moreover, ADB within the framework of a joint project with the Ministry of Agriculture of the Republic of Kazakhstan and Kazakh National Agrarian Research University from July 2019 to December 2021 conducted activities to study the condition of pastures and livestock productivity through field sampling, as well as conducted remote sensing in Akmola region.

The total budget of the project amounted to USD458 thousand.

Non-Governmental Entity "Eco Mangystau"

NPU "Eco Mangystau" is a non-partisan, non-profit and non-governmental organization that contributes to the improvement of environmental and socio-economic living conditions, improvement of the environment and preservation of its resource potential for future generations through environmental education of citizens, development of civic activity, mass environmental activities and participation in the formation of environmental and socio-economic policy of the society

For the period from 2015 to 2022, NPU "Eco Mangystau" annually organized Summer Environmental Schools for students of ecologists from Atyrau and Aktau in the number of 30 people on the theme "Conservation of the Caspian Sea biodiversity". The total budget of ecological training of students for 8 years amounted to 41.5 million tenge.

Also, a comprehensive programme of restoration of recreational areas of Mangystau region was carried out in the period from 2018 to 2019 for a total amount of 12 million tenge.

From 2016 to 2017, environmental monitoring in Mangystau region was carried out for the amount of 10 million tenge.

Civic association Center for Coordination and Information on Environmental Education "EkoObraz"

EcoObraz is a civic association located in Karaganda city with the main goal to promote sustainable development through the implementation of relevant educational programmes. Since its formation in 2012, EkoObraz has implemented projects on environmental education of youth and actions on greening the city.

In the period from January 2019 to November 2020, an event was implemented to promote agro-technologies that promote adaptation to climate change in the conditions of the desert zone of the Zhezkazgan region. Adaptive agricultural practices in arid climate conditions were tested and introduced at the pilot demonstration site of a farm. The Global Environment Facility allocated USD40,571 under the small grants programme.

Ecological Society "Green Salvation"

Since 2017 the Ecological Society "Green Salvation" is a civic association and in cooperation with public authorities and international organizations carries out public monitoring of the environmental situation in the national parks of Almaty region and sends materials to the Parliament of the Republic of Kazakhstan.

Thus, the materials: Results of monitoring of national parks of Almaty region for 2017, 2018, 2019. 2020 and 2021 have been issued.

The main attention of EE "Green Salvation" is paid to the situation in Ile-Alatau National Park, the situation in the Charyn National Park and the national park "Kolsai Lakes" is partially covered.

Most of the work was carried out on a voluntary gratuitous basis with the support of sponsors, therefore, the assessment of project implementation costs cannot be monetized.

UNESCO Office in Almaty

UNESCO implements many projects in Kazakhstan aimed at preserving cultural heritage, developing education, science, environmental protection and promoting sustainable development. The main directions of UNESCO projects in Kazakhstan in the field of biodiversity include:

Man and Biosphere Programme (MAB)

The programme is aimed at biodiversity conservation, sustainable management of natural resources and development of ecotourism.

Katon-Karagai Biosphere Reserve (year of designation: 2014, project implementation: since 2015) for sustainable management of mountain ecosystems of Altai.

<u>Programmes of ecological monitoring of rare species of plants and animals.</u>

Support for ecotourism, including the establishment of trails, information centers and training of local guides.

Aksu-Zhabagly (year of inclusion in the BR network: 2017, project implementation: from 2018)

Conservation of the biodiversity of the Tien Shan, including the snow leopard and rare plants.

Involvement of local communities in sustainable management of natural resources.

Kokshetau and Altai Reserves (year of inclusion in the network: 2018-2020, project implementation: from 2020) for the conservation of steppe and mountain ecosystems and research on the impact of climate change on biodiversity.

<u>Conservation and sustainable use of aquatic ecosystems</u>

Aral Sea basin

Ecosystem and biodiversity restoration projects (Implementation period: from 2012 to present) on biodiversity research around small lakes and floodplains of the Syrdarya River.

Development of sustainable land use and land degradation control projects and support to local communities in transition to environmentally friendly farming practices.

Rehabilitation of degraded lands

GEF/UNESCO Steppe Ecosystem Conservation Project (implementation period: 2016-2021) with main directions on combating desertification in steppe regions, restoration of pastures to preserve biodiversity and sustainability of ecosystems, and sustainable land use technologies for farmers.

Rare Species Conservation Programmes

Snow leopard and other rare species (implementation period: 2015-present) within the framework of the MAB programme and the UNESCO initiative to monitor snow leopard and red deer populations. This project included training of staff of conservation organizations and creation of corridors for wildlife migration.

Biodiversity research and monitoring

Biodiversity Inventory of Kazakhstan (implementation period: 2010-2015) on compiling a database of rare and endangered species of plants and animals, developing recommendations for sustainable management of protected areas and studying the impact of climate change on biodiversity (implementation period: 2015-2020). Research was also conducted on the impact of droughts and changes in precipitation patterns on ecosystems and the development of adaptation measures for the conservation of key species.

Supporting ecotourism

Project on development of ecological tourism in SPNA (implementation period: 2018-2022).

Creation of infrastructure for eco-tourism in specially protected natural areas (SPNA).

Training of local residents in tourism skills.

Reduction of anthropogenic pressure on ecosystems through management of tourist flows.

Mainstreaming biodiversity into national plans


Integration of biodiversity into the national sustainable development strategy (implementation period: 2016-2021) to develop recommendations on biodiversity mainstreaming in land use planning.

Conducting pilot projects in two regions of Kazakhstan.

Biodiversity education

Environmental education programmes (implementation period: from 2010 to present) to introduce ecology and sustainable development into school curricula and conduct educational campaigns for the local population.

UNESCO's total expenditures from 2015 to 2022 amounted to USD227,270.64.



Other organizations not reporting data

At the stage of discussion within the BIOFIN team of the list of non-governmental organizations, international development organizations, private companies and quasi-governmental sector entities, a list of 22 organizations represented in the Republic of Kazakhstan was formed. Further, a request to these organizations was formed.

At the same time, information and statistical

data were provided by only 8 organizations, at that the joint stock company "National Company 'Kazakh Tourism' reported that they have no proposals and additions on the issues of indirect financing of biodiversity (eco-tourism). Thus, only 36.4% of the selected organizations in the Republic of Kazakhstan provided information.


3.7. Environmental users of hazardous production facilities

According to the Bureau of National Statistics of the Agency for Strategic Planning and Reforms of the Republic of Kazakhstan, statistical reporting on environmental protection includes the following data:

- atmospheric air protection and climate change problems;
- wastewater treatment
- waste management;

- protection and rehabilitation of soil, ground and surface waters;
- biodiversity and landscape conservation.

The mining and quarrying industry is operated by private enterprises and national companies with state participation. The expenditures of the private sector and national companies on environmental protection from 2015 to 2022 amounted to 778.5 billion tenge and the amount of allocated funds is increasing annually.

At the discussion stage of the industrial sector analysis, the BIOFIN team identified 72 companies from the energy, oil and gas, mining and metallurgical and chemical sectors of industry in the Republic of Kazakhstan that make a significant negative contribution to environmental pollution and degradation.

However, from the selected list of companies only 47 companies were answered (table attached), which is 65.3% of the sample. At the same time, 21 companies are united by two mining and metallurgical holdings (Corporation Kazakhmys LLP and Eurasian Group LLP), which are represented not only by mining and metallurgical plants, but also by power and heat supply facilities.



The top 3 companies in the mining sector account for about 95.6% of all expenditures on environmental protection measures. Among these companies JSC NC KazMunayGas account for 33,069,879.70 thousand tenge or 85.23%, Kazakhmys Corporation LLP


3,084,734.28 thousand tenge or 7.95% and JSC Aluminum of Kazakhstan 941,166.82 thousand tenge or 2.43%. For the remaining 31 companies the total amount of funds spent amounted to 1,703,341.62 thousand tenge or 4.39%.

The largest volume of allocated funds falls on planting of green spaces, which is 32,001,072.24 thousand tenge or 82.5% of allocated funds. However, the volume of allocated funds has significantly increased from 57,443.43 thousand tenge in 2015 to 1,150,074.94 thousand tenge in 2022. At the same time, the maximum amount of allocated funds was observed in 2020, when 21,302,640.26 thousand tenge was spent in this direction.

These expenditures include landscaping and arrangement of the territory of the enterprise and increase in the area of green plantings, city-wide environmental action on careful treatment of trees "Green your life" and other activities.



The second place in terms of the amount of funds spent goes to activities to support NGOs working in the field of protection and development of biodiversity, for which 4,305,641.44 thousand tenge or 11.1% of the total amount of company funds were allocated.


These expenditures include charitable assistance for "Monitoring and conservation

of rare species of geese" for Kazakhstan Biodiversity Conservation Association and sponsorship for conservation of endemic species of flora and fauna of international importance to the Kazakhstan Biodiversity Conservation Fund from Eurasian Group LLP, as well as sponsorship for maintenance of the JSC "Give a Garden to the Earth" tree farm from Eurasian Energy Corporation JSC and other activities.




The third place in terms of expenditures on environmental protection measures is occupied by land reclamation, for which 2,183,131.92 thousand tenge or 5.6% of the allocated funds were spent.

These expenditures include recultivation of a quarry on extraction of clays and clay soils of a deposit "Zhalair" at "Main distributive power station Topar" LLP, recultivation of a dam of a tailing dump of Zhezkazgan enrichment factory N°1,2 at "Corporation Kazakhmys" LLP, arrangement of a sanitary protection zone of the disturbed lands of dumps of overburden rocks of quarries at Donskoy mining and processing combine, and also other actions.



The least amount of funds allocated for stocking of fishponds, which is 309,276.81 thousand tenge or 0.8% of the total amount of funds of enterprises. Allocations of funds in this direction are insignificant except for 2022, when the largest amount of money was allocated.

These expenditures include annual stocking of the Irtysh River with carp fry at JSC "Eurasian Energy Corporation", stocking of the Ilek River at Aktobe Ferroalloy Plant, stocking of the Irtysh River floodplain with fry (in honor of the 250th anniversary of ERG) at JSC "Kazakhstan Electrolysis Plant", stocking of the Kengir reservoir at Kazakhmys Corporation LLP and other activities.



Expenditure information was not provided by any of the operators of major oil and gas projects, such as Karachaganak Petroleum Operating Company, North Caspian Operating Company, and Tengizchevroil, despite their policy of openness and transparency.


For energy facilities, it is noted that these enterprises lack a unified approach, including

companies that are in the same holding. For Ekibastuz GRES-1, an official response was provided that certain measures to preserve ecosystems, wildlife resources are not carried out. At the same time, "NPP Shulbinskaya HPP" LLP, JSC "NPP Ust-Kamenogorskaya HPP", which are also part of JSC "Samruk-Energy" allocate funds for stocking the Irtysh River and planting trees.

3.8. Hunting enterprizes

Hunting management is the sphere of activity on preservation and use of hunting resources and their habitat, on creation of hunting infrastructure, provision of services in this sphere, as well as on purchase, production and sale of hunting products.

Accounting of the population of wildlife on the assigned hunting grounds is carried out by hunting organizations in accordance with the order of the Minister of Agriculture of the Republic of Kazakhstan dated March 1, 2012 N° 25-03-01/82 "On Approval of the Instruction on the accounting of animal species in the territory of the Republic of Kazakhstan".





The total amount spent on the development of hunting economy in the Republic of Kazakhstan for 8 years is 19,027,597.82


thousand tenge. At the same time, after 2020 there is a significant decrease in the allocation of funds for this direction.

The total area of hunting grounds is 143,606.0 thousand hectares. The largest hunting grounds are located in Kostanay, Aktobe and Karaganda regions, while the smallest hunting grounds are located in Turkestan,

Zhambyl and Mangystau regions. Newly formed administrative-territorial units of Zhetisu and Ulytau oblasts share their areas with Almaty and Karaganda oblasts.




Notably, despite the area of hunting grounds by oblasts of the Republic of Kazakhstan, the funding for the development of this industry differs significantly between oblasts. Thus, Akmola and Almaty regions spent the largest amount of funds for the development of these areas 6,820,374.6 and 2,611,652.9 thousand tenge respectively.

The highest expenditures in hunting enterprises are labor remuneration of rangers (17,738,123.29 thousand tenge or 60%), financing of rangers' maintenance (2,903,361.33 thousand tenge or 10%),

protection of wild animals (2,490,412.73 thousand tenge or 8%) and financing of biotechnical measures (2,123,640.34 thousand tenge or 7%).

Ranger services are created by hunting organizations at the expense of their own funds. Reproduction of fauna in the assigned hunting farms is carried out by the hunting management organization and includes a set of measures aimed at increasing and maintaining the optimal number and sustainable use of fauna objects.


Reproduction of fauna in the assigned hunting farms is carried out in order to increase the productivity of hunting grounds and is achieved by:

- feeding, creation of feeding complexes and feeding fields;
- 2) creation of artificial reservoirs and watering holes;
- 3) increasing the nesting area of hunting grounds by planting protective remizas, installing artificial nesting sites;

- 4) regulating the number of predatory animals;
- organization of scientific research in the field of protection and reproduction of fauna;
- 6) limitation of economic activities of the hunting organization in a certain territory and within certain timeframes;
- 7) carrying out measures for the prevention of animal diseases;
- 8) breeding of animals in captivity and semi- captive conditions;
- 9) introduction of fauna objects;
- 10) regulation of sex and age composition.

The wildlife exploitation in the assigned hunting enterprises is carried out by hunting organizations on the basis of permits issued by the executive body in accordance with the order of the Acting Minister of Agriculture of the Republic of Kazakhstan dated December 19, 2014 Nº 18-04/675 "On approval of the Rules of issuing permits for the use of wildlife".

Payments for the use of wildlife from 2015 to 2022 among foreign tourists who purchased vouchers for trophy hunting amounted to 33,232,849.28 thousand tenge.




Almaty (15,766,688.4 thousand tenge), Kostanay (9,203,894.2 thousand tenge) and Atyrau (2,263,738.1 thousand tenge) regions are the largest regions in terms of the number of foreign hunters and revenues for the use of wildlife.

4. FUTURE EXPENDITURES FORECAST

From 2015 to 2022 a total of 1,267,015,260 thousand tenge was spent on biodiversity conservation and development in the Republic of Kazakhstan from the republican, local budgets, as well as from the funds of international organizations, industrial

enterprises and NGOs, which is 1.25% of the GDP of the Republic of Kazakhstan in 2022 (GDP in 2022 103,765,518.2 million tenge) or 5.34% of the total consolidated state budget of the country in 2022 (budget volume in 2022 22.6 trillion tenge).



Government expenditures on biodiversity conservation activities are the largest, accounting for 74.75% (947,043,472.80 thousand tenge), international organizations' expenditures are the second largest and account for 13.55% (171,677,972 thousand

tenge), while NGO and industrial sector expenditures are insignificant, accounting for only 8.66% (109,736,343 thousand tenge) and 3.03% (38,799,122.44 thousand tenge) respectively.

Expected baseline funding under the business-as-usual scenario


According to the BIOFIN methodology, baseline funding should include all sources of funding for biodiversity conservation. In order to consider the expected expenditures, it is necessary to consider the GDP forecast

and expected fulfillment of the national and local budgets for 2024-2028.

According to the Forecast of Socio-Economic Development of the Republic of Kazakhstan


for 2024-2028, developed by the Ministry of National Economy of the Republic of Kazakhstan annual GDP growth of 5% is projected.

On this basis, the expected baseline funding under the business as usual scenario, for 2024-2028 will depend on GDP growth to further determine the financial need for biodiversity conservation.





The projected GDP growth in tenge terms is expected to increase from 118,286.9 billion tenge in 2023 to 221,518.0 billion tenge in 2028.





In order to support sustainable development of the economy, as well as to cover the budget deficit due to the possible growth of state liabilities in the upcoming 6-year period, the Government of the Republic of Kazakhstan plans to increase borrowings on domestic and foreign capital markets. Funds will be raised under guarantees and warranties of the state.


According to the Forecast of Budget Parameters and the National Fund of the Republic of Kazakhstan 2024-2026, a stable but moderate increase in revenues and expenditures of the state budget is expected.

Moreover, in the future, it is expected to increase revenues to the National Fund of the Republic of Kazakhstan for the same period on account of taxes from organizations of the oil sector (corporate income tax, mineral extraction tax, bonuses, rent tax on exports, excess profit tax, share on production sharing and additional payment of subsoil users

under the production sharing contract), revenues for violations of the terms of oil contracts, privatization of republican property and assets of national holdings and companies, sale of agricultural land plots, investment income from the management of the National Fund, and other revenues and incomes.



An important factor in the dependence of the state budget of the Republic of Kazakhstan and the tenge exchange rate is the dependence on fluctuations in oil prices. Thus, when oil prices are high, export revenues are high, which leads to an increase in budget revenues and strengthening of the

tenge. At low revenues, the budget becomes deficit, and the tenge weakens.

According to Delloite forecasts (Report: Energy, Oil and Gas Price Forecast December 31, 2022) until 2030 the oil price will be moderately stable in the range of USD75-80 per barrel of oil.

Projections of future biodiversity expenditures

According to the data of RSE "Kazhydromet" in the Republic of Kazakhstan until the middle of the 21st century, Kazakhstani scientists forecast a further increase in temperature by another 4 degrees. These changes will have a negative impact on the country's ecosystem.


Moreover, according to historical data of Kazgidromet, the volume of water resources of Kazakhstan for the last 40 years decreased by 26.4% and amounted to 91 cubic kilometers, while 76 percent of land in Kazakhstan is subject to desertification.

These negative consequences will have an impact on fisheries, forestry, fauna and flora of Kazakhstan.

Thus, a decrease in the allocation of funds from the state budget is not projected, moreover, there is a possibility of budget adjustments towards an increase in biodiversity conservation activities.

As of 2022, 1.25% of Kazakhstan's GDP or 5.34% of the country's consolidated budget was spent on biodiversity conservation activities, therefore, the forecast expenditures on biodiversity in the optimistic scenario will be in the range of 1%-1.2% of GDP or 5%-6% of the consolidated budget for the coming periods.

Also, in case of stable oil price in the range of USD70-80 per barrel, the volume of revenues to the National Fund of the Republic of Kazakhstan and to the state budget of the country will be consistently positive without periods of jumps and devaluation of the tenge.



In the next 5 years, significant allocation of funds for biodiversity will be required from a total of 1,494.29 million tenge in 2024 to 2,392.39 million tenge in 2028, which will

directly depend on the state of economic development, budget parameters, strategic goals of the state and other factors.

CONCLUSION


According to the BIOFIN methodology, to develop the biodiversity finance analysis, data on biodiversity finance by public and private sector were collected for the period from 2015 to 2022.

In the Republic of Kazakhstan, biodiversity financing activities are carried out in such sectors as forestry, protected areas and tourism, wildlife, fisheries, agriculture and water resources.

The main administrators of budget programmes implemented within the public sector are the Ministry of Ecology and Natural Resources of the Republic of Kazakhstan, the Ministry of Agriculture of the Republic of Kazakhstan, local executive bodies of the Republic of Kazakhstan, the Office of the Presidential Affairs of the Republic of Kazakhstan, the Ministry of Energy of the

Republic of Kazakhstan. The private sector includes international organizations, foreign and local donors, own funds of protected areas, forest protection institutions and hunting farms, oil and gas, mining and metallurgical and energy enterprises, as well as civic associations.

The total amount of funding for biodiversity conservation in the Republic of Kazakhstan for eight years through public expenditures is 74.75% (947,043,472.80 thousand tenge), the expenditures of international organizations are in second place in terms of volume and amount to 13.55% (171,677,972 thousand tenge), while the expenditures of NGOs and the industrial sector are insignificant, accounting for only 8.66% (109,736,343 thousand tenge) and 3.03% (38,799,122.44 thousand tenge) respectively.



When comparing annual investments in biodiversity with macroeconomic indicators, biodiversity financing for 8 years amounts to 1.08% of GDP or 4.97% of the total volume of the consolidated state budget of the country.

At the same time, there is a slight decrease in the percentage of biodiversity financing in relation to GDP. For example, the indicator in 2015 was 0.9%, and in 2022 0.78%. Currently, biodiversity financing is not a priority for both the state and the private sector.

In order to improve biodiversity financing mechanisms in the country, the Government of the Republic of Kazakhstan needs to include target indicators in the field of biodiversity conservation with precise digital designations of these target indicators in strategic documents of the highest planning level. Moreover, at the stage of budget planning in interconnection with strategic planning it is necessary to lay down budget funds for the implementation of these measures of the authorized state body.

Having analyzed all the results obtained in the course of this research, we can conclude that the existing financing of biodiversity in Kazakhstan requires changes.

Given the fact that public expenditures are the largest in terms of volume, it is necessary to maintain and increase public investment in biodiversity in the long term by including biodiversity issues in planning documents.

Regarding funding from the private sector and from natural resource users of hazardous industries, these sources show the lowest percentages.

Given the current commodity-oriented nature of the country's economy, these figures are negligible compared to the environmental damage caused. Therefore, measures should be taken to increase biodiversity financing by industrial companies through legislation and tax incentives for these companies.

In addition, it is essential to develop already available alternative sources of biodiversity financing, which may include:

- 1. Private investment, whereby private companies invest through corporate social responsibility.
- 2. Grants, sponsorship and philanthropic support from non-governmental organizations and foundations for research and conservation.
- 3. Crowdfunding through information platforms to raise funds from the general public for specific environmental projects.


- 4. Eco-tourism through the development of sustainable tourism.
- 5. Issuing green bonds or issuing bonds, the proceeds of which are used to finance environmentally sustainable projects.
- 6. Creation of social enterprises by creating business models that generate profits while contributing to environmental protection.
- 7. International financing through participation in international programmes and agreements such as the Global Environment Facility.
- 8. Public-private partnerships and concessions.
- 9. Attraction of state external borrowings.
- 10. Investment projects with participation of international financial organizations.
- 11. Incentivize local communities to establish fundraising communications with industries in their region.
- 12. Expanding areas of paid services activities in SPNAs, as well as the sale of hunting products.

According to the Kunming-Montreal Global Biodiversity Framework (KMGBF) adopted at the 15th Conference of the Parties to the CBD on December 19, 2022, under Target 19, countries need to substantially and progressively increase financial resources from all available sources in an efficient, timely and easily accessible manner, using both domestic, public, private and international resources.

According to Article 20 of the CBD, KMGBF Target 19 calls for the implementation of national biodiversity strategies and action plans, mobilizing at least USD200 billion per year by 2030. This includes mobilizing at least USD200 billion per year by 2030. Mobilizing sufficient financial resources, together with other means of implementation, is critical to achieving the targets of the KMGBF.
